# Notice Concerning Scheduled Amendments of the Articles of Incorporation, Changes in Organization, and Changes of Directors, Statutory Auditors and Important Employees in the Asset Management Company

Nomura Real Estate Master Fund, Inc. ("Nomura Master Fund" or the "Fund") announced the resolution of Nomura Real Estate Asset Management Co., Ltd. ("NREAM"), a licensed investment trust management company retained by the Fund to provide asset management services, at NREAM's Board of Directors Meeting held today, regarding the amendments of the Articles of Incorporation mainly in order to shorten the term of office of directors, and the appointment of directors and statutory auditors, which will be proposed at the Extraordinary Meeting of Shareholders as of April 1, 2017, and also regarding the changes in organization and important employees.

Furthermore, above amendments of the Articles of Incorporation, changes in organization, and changes of directors, statutory auditors and important employees, will be effective as of April 1, 2017.

#### 1. Amendments of Articles of Incorporation

NREAM has determined at the Board of Directors Meeting held today to propose at the Extraordinary Meeting of Shareholders as of April 1, 2017 agenda regarding the amendments of the Articles of Incorporation in order to shorten the term of office of directors, and partially abolish the director's special title system.

#### 2. Changes in Organization

NREAM will establish International Business Planning Section that will mainly engage in planning the business strategy of overseas asset management.

NREAM will also abolish Research & Analysis Section and establish Research & Analysis Department, for the purpose of enhancing research capabilities.

Furthermore, NREAM will abolish Product Management Department and establish Product Development Department.


