Notice Concerning the Results of Investigation in Response to the Announcement of Falsified Structural Calculation Statements by Aneha Architectural Design Office

On November 17, 2005, the Ministry of Land, Infrastructure and Transport ("MLIT") announced that Aneha Architectural Design Office ("Aneha"), located in Chiba prefecture, falsified certain structural calculation statements with respect to certain buildings, for structural calculation which Aneha was retained. In response to such announcement, Nomura Real Estate Office Fund, Inc. ("Nomura Office Fund" or the "Fund") have completed its own investigation on the involvement of Aneha in the architectural design of any of the properties held by the Fund. The Fund hereby announces that, according to the investigation, the Fund has confirmed Aneha was not in any way involved in any of the properties held by the Fund.

In addition, the Fund investigated the involvement of other architectural designers (6 designers other than Aneha) listed in the MLTI's announcements titled "Notice concerning the Falsified Structural Calculation Statements by Aneha Architectural Design Office and the Countermeasures" and "Properties, which structural calculation statements were falsified: Summary of Properties" dated November 17, 2005 and November 21, 2005, respectively. The Fund hereby announces that it also confirmed none of these designers involved in any of the properties held by the Fund in any way.

Architectural designers of the properties held by the Fund are as described in the exhibit.

The Fund will further investigate the relationship of other designers, whose possible falsification of structural calculation statements was indicated by MLIT or other sources

after November 22, 2005. If the Fund finds any material fact relating to this issue in the future, it will disclose such fact.
